- Poultry Rules**
1. All entries at owners risk
 2. The American Standard of perfection, as revised by the American Poultry Association, will be the guide for the judges awarding premiums.
 3. No exhibitor can win more than 2 prizes in one class.
 4. All entries must be owned by the exhibitor or the exhibitor's family, no combined exhibits.
 5. No unworthy specimen will be awarded a premium whether there is competition or not.
 6. Any false statement in regard to age, will exclude from competition all specimens entered by said exhibitor.
 7. All specimens must be exhibited in their natural condition. Plucking, coloring, splicing of feathers or any similar practices are in violation & bar specimens from competition.
 8. Birds entered in single class cannot compete in pens and birds entered in pen class cannot compete in single class.
 9. Each poultry exhibitor, excluding waterfowl, must comply with one of the following:
 - a. Poultry exhibited were obtained from a flock, hatchery or origin which is a participant in the National Poultry Improvement Plan for the eradication of disease. (All commercial Ohio hatcheries meet this requirement.)
 - b. Poultry are from a flock which has had a negative test for pollorum disease within 12 months, or
 - c. Poultry have had a negative test for Pollorum disease within 90 days, or
 - d. Poultry tested negative for pollorum disease at the fairgrounds by a state approved tester.
 - e. All poultry except waterfowl must have a USDA form 9-2 from hatchery or a USDA 9-3 that they can obtain from fairboard.
 10. Rules: Are to follow Jr. Fair rules.
 11. After Jr. Fair cage assignments - Sr. Fair Board will assign Sr. Fair entrants a cage on a first come basis.
